# THE 16TH ANNUAL MEETING OF THE COUNCIL FOR THE MALTESE LIVING ABROAD (CMLA)

The Council for the Maltese Living Abroad convened for its annual meeting on the 30<sup>th</sup> and the 31<sup>st</sup> of October 2024 at Palazzo Spinola in St Julian's. Comprised of 15 members, including representatives from Australia, the United States, the European Union, and the United Kingdom, the Council gathered in Malta to discuss its work, address issues faced by Maltese communities abroad, share ideas and proposals, and devise a strategic roadmap for the future of the Council. The meeting, chaired by Deputy Prime Minister and Minister for Foreign and European Affairs and Trade Ian Borg, also included a discussion with President Myriam Spiteri Debono on challenges faced by the Maltese diaspora. Key topics included the Maltese language, citizenship, regional councils, as well as a number of presentations on collaborations with other entities.

# MALTA'S POPULATION - ONE IN FOUR IS NON-MALTESE

According to the National Statistics Office, more than 542,051 people live in Malta at the end of 2022, with 137,376 – or just over 25% – being foreign nationals. Based on this new data, the number of foreigners living in Malta since then has jumped by 8,534 people, a rise of 6.2%. The 2024 population density in Malta is 1686 people per Km<sup>2</sup> (4,367 people per mi<sup>2</sup>), calculated on a total land area of 320 Km2 (124 sq. miles).

# **MEMORIES - Dar l-Emigrant, Valletta 1971**

The Late Mgr Philip Calleja was recognised for his lifelong sterling work Laying the foundation stone of Dar I-Emigrant in 1971: standing on the right are Archbishop

February 10, 2021, marked the 50th anniversary of the laying of the foundation stone of Dar l-Emigrant, Castille Place, Valletta.

The building was erected as a permanent symbol of this country's tribute to Maltese emigrants and a monument witnessing Malta's bond with them. Its foundation stone was laid by Prime Minister George Borg Olivier and blessed by Archbishop Mgr Michael Gonzi.

This building was an appreciation to all those who have always had the best interests of Maltese emigrants and their families at heart, primarily Mgr Philip Calleja, the indefatigable former leader of the Emigrants' Commission. Mgr Calleja dedicated his life to uprooted people, first as the champion of post-war Maltese migrants and their families and then as the leading pioneer defender of refugees seeking protection and help in Malta.



Up to March 2020, at the venerable age of 91, the late Mgr Calleja was still regularly making himself available at *Dar l-Emigrant* to help whoever knocked on his door seeking his advice or assistance. It was only the COVID-19 pandemic and the indispensable precautions that had to be taken that <u>kept him</u> <u>away</u> from *Dar l-Emigrant* and what is most dear to him: helping others.

The late very able researcher and historian Fr Lawrence Attard OP, writing in the Times of Malta on June 24, 1975, on the occasion of the 25th anniversary of the Emigrants' Commission, had this to say:

"The history of migration from these islands, especially post-war migration, is now to a great extent the history of the Emigrants' Commission. That commission was providentially fortunate in that, since 1953, it has had as its driving force Mgr Philip Calleja, who, since then, has dedicated his priestly life to migrants and to all people whose life has been affected by emigration.

Mgr Philip Calleja was the champion of post-war Maltese migrants and their families as well as of refugees seeking protection and help in Malta- Charles Buttigieg

"The enthusiasm of Mgr Calleja has inspired a dedicated group of people who willingly offer their services to prospective migrants, to their dependants and to Maltese living abroad. These services are given to all who seek the help of the commission; no fees are charged, no irrelevant questions asked and the whole procedure is conducted by experienced priests and lay people in total privacy."

Mgr Calleja enjoys various international and local recognitions for his lifelong sterling work for Maltese emigrants and asylum seekers reaching Malta.

On March, 16, 2010, Stephen Gatt, president of the Federation of Maltese Abroad, presented to Mgr Calleja a plaque which states as follows: "In recognition of a lifetime of service, labour and travail well in excess of the call of duty in the interests of Maltese migrants across the diaspora."

Mgr Calleja was also granted certification by the United Nations High Commissioner for Refugees (UNHCR) on September 23, 2004 "in appreciation for years of dedicated service and close collaboration".

The Emigrants' Commission was the UNHCR's operational partner in Malta from 1987 to 2004, when the UN agency's role in the island had taken a new form in the light of Malta's Refugees Act.

On November 1, 2019, Mgr Calleja was also honoured by the University of Malta, acclaiming him "a meritorious candidate for the degree of Master of Letters (Honoris Causa) of this Alma Mater".

In its motivation, the university recognised "the significant contribution made by Philip Calleja to the social well-being of our communities, especially through his persevering commitment to the welfare of migrants and his contribution to the process of relocation; through his role as founder of the Migrants Commission.

# **OPINION OF OUR READERD**

My proposal is to deal with issues relating to diaspora citizens

- 1. voting in both the Malta general elections and EU parliament,
- 2. distance voting in all elections and
- 3. the addition of one diaspora electoral district and two elected observers with no voting rights to the Maltese Parliament with negligible impact on the current operation of the Maltese Parliament.

The three matters - Voting Rights, Distance Voting and Maltese Karta tal-Identita - are of vital importance to diaspora Maltese citizens. It is worth noting that I have worked on this concept (proposal) with HE Dr George Vella, President Emeritus, The Hon Tonio Borg, The Hon Carmelo Abela, Prof Carmen Sammut, and several members of FOMA and the CMLA. All generally understand that my draft proposals are plausible and worthwhile, and they would finally solve many flaws in how we deal with citizens living overseas. # CONSULAR PLUS

#### USEFUL INFORMATION FOR MALTESE LIVING ABROAD

In recent years, there was a

considerable increase in the number of Maltese nationals travelling abroad for business or leisure. While this is a positive sign, it has also brought about a new set of challenges and a significant increase in requests for consular assistance, the majority of which could be easily avoided if travellers are properly guided about what to do prior to travel.

Consular assistance is regulated by the Vienna Convention on Consular Relations (1963) and consists of an array of consular issues related but not limited to cases taking place abroad and involving Maltese nationals. Issues range from loss/stolen or expired passports to hospitalisation and deaths, violence and criminal offence, family disputes and deportation of Maltese nationals.

Further, consular assistance also includes legal matters in the form of notifications on maritime contraventions, transmission and processing of rogatory letters, EFTA Court documentation, information related to deaths/incidents of foreign nationals, documentation for request for transfer of sentenced persons, transfer or request for extradition of local/foreign nationals.

The General Consular Affairs Unit which forms part of the Client Service Office (CSO) also handles requests received by foreign missions to visit foreign inmates at the Correctional Service Agency and the setting up of polling stations in Malta by Embassies for foreigners living in Malta to be able to vote in elections taking place in their homeland.

#### The Directorate for Consular Services and Maltese Living Abroad

The Directorate assists all Maltese travellers who find themselves in distress whilst abroad. In such situations, the Directorate acts as the main point of contact between the individual who is abroad and his/her family in Malta, to facilitate any possible support and ensure that all services rendered are provided in the best possible manner and in a timely order.

#### Who to contact in case of emergency

The Ministry provides emergency consular assistance 24 hours a day including weekends and public holidays. If you are abroad and need help, you can call the Maltese Embassy, the High Commission or the Consulate in the country you are visiting, when present, or the Ministry in Valletta. After office hours, the Ministry operates through a Duty Officer who takes note of your request and, if possible, assists immediately. When immediate assistance is not possible, your request will be referred for action to the officers in charge at the Consular Services and Maltese Living Abroad Directorate. You can access addresses and telephone numbers of Missions abroad online by clicking on **Malta Representations** and **Find Representation**, and select the country of which you require Malta's diplomatic contacts. #### Assistance to Maltese citizens in distress whilst abroad

If Maltese nationals need emergency assistance while abroad, they should either contact the nearest Maltese Embassy or Consulate; or the Ministry on 00356 21 242 191 which provides emergency consular assistance 24/7. The Ministry operates an after-office hours service through a

Duty Officer who takes note of requests and if possible, assist immediately. When immediate assistance is not possible, requests will be referred for action to the Consular Service Office.

#### Public Registry Certificates (Life Events)

The Public Registry is responsible for the issuance of birth, marriage, civil union, free status and death certificates. The certificates can be ordered in person from the Public Registry Office in Marsa or online on www.certifikati.gov.mt and have them delivered to an address of one's choice. When ordered online, a certificate can also be ordered with an Apostille/Legalization certificate. More information regarding the services offered by the Public Registry website.

#### **Maltese Passports**

The Passport Office which falls under the remit of Identity Malta issues a Maltese passport to Maltese citizens and assists Maltese Embassies and Maltese High Commissions abroad to issue or renew Maltese passports for Maltese citizens residing abroad. The validity of an ordinary Maltese passport is ten years for adults over 16 years, five years for minors between 10 and 15 and two years for minors under 10 years of age. More details about the Maltese passport can be obtained on the Passports Office website.

#### Maltese Citizenship

Community Malta Agency is responsible for administering Maltese citizenship applications. The Agency processes applications for the acquisition of Maltese citizenship by birth, by registration, by naturalisation through long term residence, by merit for exceptional services and for exceptional services by direct investment in Malta. More details about the acquisition of Maltese citizenship can be obtained from the Community Malta Agency website.

Voluntary Registration for Maltese Citizens Living Abroad

The Maltese living Abroad register comprises of the voluntary notification of Maltese

Diaspora. This voluntary notification seeks to further inform, strengthen and compliment the consular services offered by the Maltese Government.



# Villa Portelli, Main Guard, Jesuit church among 40 restoration projects

Owen Bonnici says Budget 2025 will ensure preservation of Malta's history Emma Borg

Forty restoration projects will kick off, continue, or be completed over the coming year, the Culture Minister said. Speaking at Villa Guardamangia - one of the key projects on the list - Owen Bonnici outlined how the 2025 budget will impact the culture sector and ensure the preservation of Malta's historical assets. The extensive list includes ongoing projects and new initiatives to enhance cultural heritage sites.

The main projects include:

- Villa Guardamangia in Pietà, with an investment of €10.2 million in European funds;
- Villa Portelli in Kalkara, with an investment of around €800,000 over this year and next;
- The Jesuit Church in Valletta, with a total investment of €4.5 million;
- The Maritime Museum in Birgu, set for completion by 2027;
- The World War II Victims Monument in Floriana;
- The additional fortification restorations of the Cottonera and Santa Margerita Lines;
- The Vendome Tower in Marsaxlokk;
- The San Ġwann t'Għuxa Windmill in Cospicua;
- The Marsa Tram Station.

Another significant project is the Main Guard building in Valletta's St George's Square. Heritage Malta will oversee its restoration with €600,000 in national funds, with a target completion date of 2027. The Main Guard was initially built as a guardhouse in 1603 by the Order of St John, and it remained in use after the British took over.

"This is a strong restoration programme that will continue to beautify our country, safeguard the unique heritage of our islands, and, above all, provide Maltese and Gozitan families with a country of quality," Bonnici said.

Malta's cultural footprint will expand internationally in 2025, as the country participates for the first time in the prestigious Gwangju Biennale in South Korea.

Additional developments include a Sculpture Garden at <u>the Malta International Contemporary Art</u> <u>Space (MICAS)</u>, which will receive €600,000 in funding, and a €3 million investment in Malex House, which is the property of PBS. This project will include an underground car park, a large studio, and office spaces equipped with state-of-the-art technology.

A new site in Paola is also being developed to provide studios and offices for dancers and artists, a collaborative project with MCAST and the Performing Arts Agency.

"A quality country is recognised not only by its economic success but also, and importantly, by how well it cares for its heritage, arts, and cultural sectors," said Bonnici.

The minister also highlighted several recently completed projects, including the restoration of the Grandmaster's Palace and the launch of MICAS in 2024. With these successfully concluded, he indicated that the next primary focus would be the <u>Culture and Arts Hub</u> in Marsa. He noted that Festivals Malta would soon issue the first of two tenders for this project following recent budget allocations.

Following the premiere of Fish Isle Films' feature documentary in 2023 in Malta and its recent win at the German International Film Festival 2024, it is now time for the New South Wales audience to see the insightful and moving documentary Who Would You Tell?.

With the promises of a better future in a new foreign land, "WHO WOULD YOU TELL?", which is coproduced by Fish Isle Films and Strada Reali tells the story of three brothers from Malta separated from their destitute family at a young age and sent to Tardun in Western Australia under the child migration scheme. What was supposed to be a second chance turned into a lifetime of regret, pain and missed opportunities that deeply affected their journey to adulthood.

Fifty years on, Raphael, Peter and Manny reflect on their stolen childhood and how the sexual, emotional, and physical abuse they experienced shaped their entire life.

Through interviews and archive materials, the documentary navigates back through their memories of abuse, homesickness and severed family ties. Their story unravels the historic failure of a scheme backed by two governments; the broken promises of the Catholic Organisation that received them; and features outcomes of the Royal Commission into Institutional Responses to Child Sexual Abuse recommended by then Prime Minister, Julia Gillard in 2012.


Wirt Ghawdex will be hosting an open day at St Cecilia Chapel on 17 November, a few days before the feast of St Cecilia, the patron saint of music. The event will be held between 10am and 5pm.

In a statement, the NGO said said the general public can visit the medieval chapel, which is the only one in Gozo from this period. They can also join a guided tour, besides buying food and drinks and books, which will be on sale.

There also specific events being held on the day. # SALUTATION Peace be with You

The custom of exchanging the greeting of peace at Mass is found in the words of St Augustine in the 4th century: "After the Lord's Prayer, say 'Peace be with you.' Christians then embrace one another with a holy kiss. This is the sign of peace."

In the primitive church at Rome and in the Eastern Church, the kiss of peace was offered after the first part of the Mass

and before the Eucharistic Prayer. Early baptismal documents also indicate that the exchange of peace was reserved only for the 'faithful,' and so catechumens were dismissed before the Prayer of the Faithful, which was followed by the Kiss of Peace. In the Western Church the sign of peace was moved quite early to where it is as Augustine described it and where it is today. The Western Church saw a close link between peace and communion–peace with one another before receiving the Prince of Peace. In the Middle Ages the laity were excluded from the sign of peace and it was then dropped altogether from the Mass; the only remnant of the rite was the action of the priest kissing the altar Vatican II restored the ancient rite of peace to all who participate at Mass.

During one Easter period in 1957, I met the late Archbishop Justin Simonds coming out of the sacristy at St Mary's church, West Melbourne. He stopped to speak with me and said: "I heard that the greeting among yourselves is "Peace be with you". The Archbishop commented that it was a wonderful greeting and should be used among all Christians. He also said that he would be going to Rome for the 'ad limina' visit and would suggest the idea to Pope Pius XII.

On his return from Rome, he told me that the Pope liked the idea very much. It may seem presumptuous that this idea came directly from the Society of Christian Doctrine but is it possible that this suggestion to the Pope by Archbishop Simonds may have assisted in the re-introduction of this greeting into the Liturgy.

# THE REGISTERS OF BIRTHS, DEATHS AND MARRIAGES IN MALTA AND GOZO TO OUR ANCESTORS

This article looks at the registers of births, deaths and marriages since the arrival of the Hospitallers (Knights of St John) in 1530. From then on, the Church kept registers of these events until 1889 when the Public Registry of the Maltese Colonial Government assumed responsibility for this function.

In Europe, the 16<sup>th</sup> century was a period of great religious turmoil that divided people, towns and nations. The Catholic Church which for centuries was the dominant religion, had lost its way, as corruption, greed, nepotism, and immorality undermined the very foundations of this great institution. An anti-Catholic movement known as Protestantism quickly grew and spread across northern Europe and "threatened to annihilate" the Catholic Church. Alarmed by the spread of Protestantism, Pope Paul III (1534–1549) convened the Council of Trent (1545–1563) to reform the Church and to repel the spread of Protestantism. Among the Council's many reforming decrees,



were two which are essential to this article: (i) parish churches were to keep registers of births, deaths and marriages and (ii) aspirants to the priesthood were to be trained and educated in a diocesan seminary.

The parochial registers contained details of practising Catholics. Anyone not on the registers was presumed to be a non-practising Catholic or a Protestant and could be investigated by the Inquisition. This reform imposed certain rights and obligations on the parishioners.

Baptism was the entry point to the Catholic Church. Therefore, a Catholic family was obliged to baptise their newborn baby and the officiating parish priest was required to

record the event in the Register of Births. A Catholic couple had a right to marry in the parish church, subject to satisfying certain conditions including that they were free to marry for life. Again, the officiating parish priest was required to record this event in the Register of Marriages. Finally, there was the "Liber de Statu Animarum", a register kept by the parish priest containing details such as names of family members, relationships, births, address, and sacraments such as confirmation, confession, communion, marriage and death. After the Council of Trent, the Church started recording every important life event of parishioners in the parochial registers.

Despite this registration system, the Church in Malta faced many external and internal threats. Protestantism arrived in Malta and found adherents among the educated people. These also acquired and read books forbidden by the Church. Then there were religious crimes including sorcery, witchcraft, bigamy, breaking the rules of fasting and abstinence, blasphemy or swearing and apostasy. These religious crimes were likely to be prevalent in the crowded streets, houses and taverns of Valletta, Birgu, Senglea and Cospicua. In these cosmopolitan harbour towns, the Maltese mixed with foreign sailors, visitors and merchants, some coming from Protestant countries. They exchanged news on happenings in Europe or money for a book forbidden by the Church.

In an attempt to stop the spread of anti-Catholic behaviour, the Pope established the Inquisition, a Church tribunal or court with its own judges, prosecutors, prisons etc to investigate, prosecute and

punish heretics and people who committed religious crimes. The Inquisition encouraged Catholics to denounce people whose behaviour was suspicious. The punishment for these religious crimes depended on the nature of the crime: some offenders received a spiritual punishment (e.g. going to mass), some were flogged, some were exiled from Malta for a number of years, some were executed in public (burning), some were condemned to rowing on the galleys and some were fined and had their assets confiscated.

In July 1574, Pope Gregory XIII (1502-1585) sent the Italian Mgr. (Monsignor) Pietro Dusina to Malta to ensure that the Church had taken steps to implement the reforms of the Council of Trent, to stamp out heresy and religious crimes and to resolve the differences between Bishop Royas and the Grand Master La Cassiere. Mgr. Dusina was the first full time inquisitor of Malta. He was an energetic and hard working priest who, during his short stay in our islands, visited about 430 churches and chapels and wrote a detailed account of the religious life in our islands. In his role as inquisitor, Mgr. Dusina presided over twenty-five cases including those against Judge Dottor Ludovico Platomone and Don Pancratio Michallef, Archdeacon of the Cathedral, who were found guilty of conversing with heretics. In Malta the Inquisitor's Court was located in Birgu.



The Hospitallers came to rely on the four registers kept by the Church to estimate the population of our islands and the amount of grain required to be imported from Sicily to feed the population of our islands.

England, our colonial masters, also relied on the Church of England parish registers which did not include the births, deaths and marriages of Catholics and non-conformists. Accordingly, on 1<sup>st</sup> July 1837 the British government introduced the civil registration of births, deaths and marriages which applied to all people living in England irrespective of their religious beliefs. In Malta, civil registration was introduced on 3<sup>rd</sup> August 1889, when the Colonial government established the Public Registry which took over responsibility for the recording of births, marriages and deaths. The records of the Public Registry, however, goes back to 1864. So, if you want to get a

birth certificate of one of your ancestors who was born before 1864, you have to go to the parish church. If he/she was born after 1863 you have to go to Identita` Malta.

The registers of births, deaths and marriages for some parishes have been microfilmed and are freely available on the Maltese Diocesan Archives website (<u>https://archives.church.mt/</u>). The family tree on my father's side includes the names of my ancestors and their date of marriage. Recently I was able to trace their marriage in the microfilmed parish records. My earliest known ancestor married in 1595 in Siggiewi and he was probably born in 1575. It is fair to say that his father probably fought in the Great Siege of 1565.

At the time of the visit of Mgr. Pietro Dusina in 1574-75, the church did not have seminaries for the formation of priests. Mgr. Pietro Dusina recommended the establishment of a seminary in Malta. Education of priests started to improve: after 1570s the Dominicans established a school in Valletta for the education of Dominicans and lay priests; then in 1593, the Jesuits established a college in Valletta which was also a seminary. Later this college became the University of Malta; in 1703 Bishop Fr Davide Cocco Palmieri (1632 – 1711) founded the seminary in Mdina. The improvement in the education of priests is evident from the marriage records of my ancestors: one marriage record of 1632 had three lines, the handwriting was not neat and the lines were slanting; on the other hand, the marriage record of 1722 had eight lines, the handwriting was very neat and the lines were straight.



It is hard to believe it was over Malta that Britain and France had gone to war again in 1803 after a peace deal that lasted only 14 months. Why did Britain hold its ground, and why did when he was conquering Europe?

Bonaparte concentrate on Malta so much when he was conquering Europe? *Napoleon: 'Malta or War'*, just published by Kite Group, gives an in-depth historical account of the negotiations that led to the Treaty of Amiens and of the interminable twists and turns in the arguments over Malta's possession.

It explores Britain's shift in policy over Malta and the Mediterranean, Russia's part in the interplay of diplomatic manoeuvres, and brings to life the contributions of the leading actors in the fast-moving events that led to the Napoleonic Wars and Napoleon's downfall.

Victor Aquilina's latest deeply researched publication delves into an area that has been mostly overlooked by historians and it is essential reading for all those interested in this momentous period.

Aquilina, a former editor of *Times of Malta*, is the author of a number of other books, including *Lord Strickland: Plots and Intrigue in Colonial Malta* and *Churchill, Malta, and Gibraltar*.



The Shadow: Poems for the Children of Gaza is a poignant collection of 42 original poems by Ahmed Miqdad and John P. Portelli, capturing their emotional struggles against personal and collective adversities, ultimately serving as a testament to poetry's power to inspire hope and resilience amidst hardship.

*The Shadow: Poems for the Children of Gaza* (Malta: Horizons, October 2024) is a collection of 42 original poems (21 by Ahmed Miqdad, 21 by John P. Portelli) which depict the state of being of the two authors since October 2023. Both wrote these poems during a time of struggle: Ahmed with the continuous inhumane oppression of Israel which began in 1948; John with cancer. Miqdad and Portelli through a poetic dialogue with each other share their emotional struggles when facing life and history.



According to Ghassan Zaqtan, an Palestinian internationally renowned poet and award winner: "These poems are an extension of personal destiny in an imagined and real geography. The two poet's intuition reveals a side path that leads to friendship. The poems exhibit an anxiety that grows parallel to the scenes provided so that they have a shadow. Anxiety is the charm of these poems, and it brings together the imagination of poetry with the imagination of place." The collection includes a brief but insightful introduction by Professor Jamil Khader former Professor of English and Dean of Research at Bethlehem University, West Bank. Professor Khader noted: "In a world where both personal and collective histories are threatened, this collection serves as a testament to the power of poetry to preserve life in the face of death and to give us hope, purpose, and the strength to endure. These poems embody acts of defiance against the forces that seek to

erase life."

The collection is available from Horizons Malta and Agenda Bookstores. All proceeds from the sale of this book will be donated to Gaza. The book will also be on sale at the Malta Book Festival.



# A GOZITAN WOMAN IN MELBOURNE KILLED IN A FREAK CAR ACCIDENT

MaryAnne Cutajar born in Gozo and mother of 4 was killed in a freak incident on a Melbourne city freeway. Mary-Anne Cutajar, 46, was driving on the M80 Ring Rd in St Albans when a metal object authorities believe came loose from a passing truck smashed through her windscreen about 4pm on Thursday.

No one else was in the car with the Deer Park woman and she died at the scene. She was driving behind a truck when a ramp fell off and struck her car. The white truck

was driving Altona-bound on the Western Ring Road at about 4pm on Thursday when the a piece of metal came off. The ramp careered into the Greensborough-bound lanes and struck Cutajar's car near the Furlong Road exit, in St Albans. It was unclear whether the truck driver was aware of the accident, and by Thursday evening, the police were still hunting them down. The mother and wife have been remembered by her family as a "beautiful soul" in the aftermath of her tragic death.
