





# GAR Our Nation's Diaspora



Public Talk at Il-ĦaġarThe next public talk of the Saturday morning series at Il-Ħaġar, happening on 1 st of November at 11:00 and delivered by Dr Raymond C. Xerri, should be the first in the history of our nation to present scientifically researched, data-driven estimates of how many people of Gozitan and Maltese origin live worldwide today. Global Gozo and Global Malta reveal that 410,000 Gozitans and 380,000 Maltese reside beyond our shores, making a combined diaspora of 800,000, from the first to fifth generations.

This striking reality shows that Gozo, proportionally, has one of the largest diasporas globally, while Malta ranks among the world's smallest island states with one of the highest outward populations. Beyond statistics, this lecture addresses the urgent dilemma we face: the need to embrace maturity as

an 'international nation', with citizens in 171 countries and territories. It explores the economic potential of this global community, highlighting countless opportunities for mutually beneficial initiatives. Ultimately, it

redefines Malta and Gozo as international peoples with far greater reach, unity, and promise than ever imagined.

Born in New York to Gozitan parents, Chevallier Dr Raymond C. Xerri is a career diplomat of 30 years with postings across five continents. He currently heads the Gozo Diaspora & International Office within the Ministry of Gozo and Planning and serves as President of Europeans Throughout The World (ETTW), representing 480 million Europeans globally. A recognised researcher with a doctorate in Gozitan Diaspora Studies, he is also an academic, author, curator and award-winning community leader. Admission is free but seat reservations are advised. #### THOUSANDS ATTEND FESTA IKEL MALTI 2025 AT TA' QALI

13 October 2025



Thousands of people attended this year's Festa Ikel Malti, which was organised by the Malta Food Agency and held on Sunday, 12 October, at Pitkalija in Ta' Qali, the government said.

The event, celebrated just days before World Food Day on 16th October, focused on promoting sustainability, local produce, and Maltese identity through food.

The festival offered families a day filled with gastronomy, music, heritage, and creativity. Visitors enjoyed exhibitions and sales of agricultural products, educational activities for children, and demonstrations highlighting the importance of fresh food and sustainability within the food chain.

Minister for Agriculture, Fisheries and Animal Rights Anton Refalo praised the Malta Food Agency and the turnout, stating that the event showed unity between the community and those who work to bring Maltese produce to local tables. He emphasised that food remains a central part of Maltese and Gozitan identity and commended farmers, herders, and fishermen for their dedication to providing fresh, quality produce.

Parliamentary Secretary for Fisheries, Aquaculture and Animal Rights Alicia Bugeja Said also highlighted the event's role in commemorating Malta's culinary heritage. She thanked the Malta Food Agency for its organisation, noting that Festa Ikel Malti continues to promote local and quality products thanks to the passion of Maltese and Gozitan producers.

Malta Food Agency Chief Executive Brian Vella expressed gratitude to the thousands of attendees and the more than 40 producers who took part. He stated that "this feast was not only a celebration of our products, but also of those who make them possible - the farmers, fishermen, herders and producers whose work and dedication give strength to the Maltese food sector." Vella added that the event served as "an occasion to pay tribute to the men and women who raise, harvest and create authentic products that represent the best of Malta."

The Ministry for Agriculture, Fisheries and Animal Rights and the Malta Food Agency said the high turnout reflects the growing public interest in locally sourced food and the efforts being made to promote sustainability within the agricultural sector.

#### PRAYER MEETS ACTION: THE CHAPLAINS OF THE ORDER OF MALTA AUSTRALIA

The Order of Malta is founded on a unique and enduring mission: to defend the faith and to serve the sick and the poor. In Australia, this mission is brought to life in a powerful way through the work of the Order's chaplains, who serve not only as spiritual leaders, but as active participants - and sometimes initiators - of charitable works across the country.

Guiding in Faith, Leading in Service

Chaplains within the Order of Malta Australia provide extensive liturgical support to members and candidates, making the Order for many a true 'spiritual home'. Their contributions include:

Monthly Vigil Masses for members

Monthly Online spiritual reflections that offer encouragement and formation

Leadership at retreats and special liturgical events

Preparation of candidates and ongoing formation of members

But their role goes well beyond spiritual guidance. Chaplains are actively engaged in hands-on service, often working alongside members and volunteers in some of the Order's most impactful charitable initiatives.

"As part of their formation, we encourage our chaplains to actively participate in the Order's charitable projects - not just to observe, but to engage meaningfully with our members, volunteers, and, most importantly, those we serve" explains John Murphy, President of the Australian Association. "It is through this shared experience that our chaplains come to understand the unique charism of the Order of Malta: faith lived through service. This connection grounds their spiritual leadership in the very heart of our mission."

From supporting food services and homeless outreach street missions, to participating in the Order's Camps for Disabled Youth, chaplains are a visible and compassionate presence—bringing both spiritual comfort and practical assistance to those in need.

Chaplains as Project Leaders Order of Malta chaplains are not only participants in charitable works—they are often key drivers of new initiatives.

In the well-known beachside suburb of Bondi, Sydney, the Order of Malta Community Care Kitchen has been serving nutritious, home-cooked meals to the homeless, disadvantaged, and isolated for the past four years. Each service welcomes around 30 guests, offering not just food, but a sense of dignity and belonging. This initiative was launched by Conventual Chaplain ad honorem, Fr Anthony Robbie, and continues to operate from his parish.

"We aim to provide a hearty home-cooked meal of the standard that we would serve to valued visitors in our own homes," said Fr Robbie. "For many of our guests, it's the only nutritious quality meal they'll have all week—and the social interaction is just as important."

In Queensland, another chaplain-led initiative is nearing completion. Philermos House, located in Southport, is scheduled to open later this year. The project is the result of the vision and dedication of Chaplain Fr Gerard McMorrow, in partnership with the Archdiocese of Brisbane and the Order of Malta. Fr McMorrow, who serves as parish priest at Southport, recognised a growing need in his local community. Philermos House will provide meals, showers, laundry facilities, medical services, and recreational spaces for homeless individuals, low-income families, and others on the margins. It is anticipated that the centre will serve between 150–200 people daily.

The facility, located on parish property, will be managed and operated by the Order of Malta, offering a secure, hospitable, and respectful environment for those most in need.

A Living Witness to Faith in Action



# NEW EXHIBITION MARKS A CENTURY OF SAFEGUARDING MALTA'S HERITAGE

Heritage Malta has unveiled a new exhibition at the National Museum of Archaeology in Valletta, marking 100 years since the first law protecting Malta's heritage. The display reveals how the island's ancient past came to be recognised as a national treasure worthy of preservation. The exhibition runs until the end of January 2026.

Titled 'From Destruction to Preservation: Towards the Antiquities Protection Act (1925)', this latest entry in the Espresso series examines the key developments that led to the law which laid the foundations for heritage protection in Malta

By the turn of the 20th century, Malta's archaeological sites were increasingly threatened by unregulated excavations and trade in antiquities. Early preservation efforts, including the founding of the national museum in 1903 under Dr

Themistocles Zammit, helped establish the institutional framework and public awareness that ultimately enabled first the 1910 Protection of Antiquities Ordinance and later the 1925 Antiquities Protection Act.

The exhibition features rare documents from the National Archives and photographs from the museum's own archive, including documentation of the now-destroyed Kerċem Neolithic site in Gozo and the Buqana site. As a result of the 1910 Protection of Antiquities Ordinance, the latter was in fact the first Neolithic burial ground discovered after the celebrated Hal Saflieni Hypogeum which was systematically recorded. Nevertheless, damage to other sites, such as at Mtarfa, revealed the shortcomings of that ordinance, underscoring the need for stronger, more comprehensive legislation. By revisiting these crucial milestones, the exhibition invites visitors to reflect on a century of heritage management and on Malta's enduring commitment to protecting its cultural legacy.

The exhibition remains open until the 31st of January 2026. Until the end of October, the exhibition opens daily from 09:00 till 19:00, and subsequent times will be available on https://heritagemalta.mt/opening-hours/. Admission is free, and the exhibition space is fully accessible. An illustrated catalogue complements this exhibition – available at the museum and through Heritage Malta's online




# IN LOVING MEMORY OF JOE CAMILLERI FROM VICTORIA - AUSTRALIA

#### **CAUGHT BETWEEN EMPIRES: THE MALTESE TRIPOLINI STORY**

Dr Mario Xuereb presents a lecture that sheds light on the forgotten Maltese of Tripoli - a migrant community that during the interwar years was caught between empires, languages and loyalties. Drawing on original research, the lecture traces how the Maltese Tripolini found themselves in a precarious position as British subjects under Italian colonial rule. When Italian laws clashed with British regulations, hundreds of families - especially children born outside marriage - slipped through the cracks and became stateless. Dr Xuereb examines the human cost of bureaucracy, colonialism and empire, showing how ordinary people were forced to navigate shifting borders and competing claims of identity. Many Maltese Tripolini tried to hold on to their British nationality while resisting pressure to become Italian, and yet were often rejected by both. As war approached, their ambiguous status made them targets of suspicion and during the war the entire community was deported to internment and concentration camps on mainland Italy.

#### **MALTESE TRIPOLINI**

In June 1940 Italy set in motion a series of provisions for the internment of enemy aliens on the mainland and its colonies. Over the next few years, the entire community of Maltese Tripolini – all British subjects by birth or ancestry who for decades had been settled in Tripoli and Benghazi – faced detention, exile, expulsion, and deportation. The Italian Governor of Libya cited the need 'to repress the espionage inherent in treacherous elements' among the 'political and military reasons' for the deportations. Despite the nature of the circumstances, historiography has ignored the whole episode. Using untapped primary sources held in Maltese, British and Italian archives, this paper delves into the deportation of whole families from the Italian colony of Libya and explains the spatial, temporal, and legal contexts. These same sources have made possible the naming of all the anglomaltesi, known to have been placed in concentration camps or subjected to *internamento in comune libero*. It concludes that 1,672 Maltese Tripolini were deported from Tripoli to Italy, equivalent to nine-tenths of the community. Sources also reveal the names of those born in concentration camps and the circumstances of those who lost their lives during internment.

One of the most beautiful prayers that was written during the early stages of the 20<sup>th</sup>. Century is The prayer of Serenity. This prayer was attributed to the theologian Reinhold Neibuhr. By following a constant Utopian style vision and unfocused life, we will probably be quiet close to reach our very rock bottom situation and destination too. Perhaps that would be the most precious and important moment in our distracted life to come to terms with our emptiness and start crawling up once again to live a more decent, peaceful and mature life.

"Living one day at a time, enjoying one moment at a time accepting hardship as a pathway to peace, taking as Jesus did, this sinful world as it is, not as I would have it,

trusting that you will make all things right, if I surrender to Your will,

so that I may be reasonably happy in this life, and supremely happy with you forever in the next."

This is the challenge that we have to live with. We can fail by taking Christ as for granted, ignoring his truthfulness, love and his sense of powerlessness, and embark on our pride, egotism and false illusions. Yet, by adhering to His guidance, peace and fatherly attitude, we will live a life capable enough to gibe us that moral balance so as to be in harmony with God, with ourselves and with all those living around us.

# FR RAYMOND PORTELLI – THE PRIEST-DOCTOR IN PERU

Fr Raymond Portelli, hailing from Nadur, Gozo, has dedicated the past 17 years of his life to serving in the heart of the Peruvian Amazon, specifically in the vibrant town of Iquitos, located just a two-hour flight from Lima. After completing his philosophy studies in Gozo, he was inspired to embark on a sabbatical year in Peru upon the recommendation of Fr Arthur Vella S.J., who was then the spiritual director at the Seminary of Gozo.

Since his arrival in Iquitos as a priest, Fr Raymond has been instrumental in organizing numerous religious activities. He oversees a dedicated group of 430 agentes de pastorales who assist him in managing the parish's various needs. In Iquitos, sadly, societal challenges are stark women often find




themselves marginalized, treated as expendable. The scourge of AIDS and drug addiction is prevalent, with young girls as young as 12 or 13 often facing the expectation of early motherhood to secure the labour force for their families. Despite these challenges, the aspiration to become a doctor never faded for Fr Raymond.

After receiving approval from his superiors, he enrolled in the medicine program at the State University of Amazonas, conveniently located just half an hour from his parish. Now, while fulfilling his priestly duties, he also tends to the health needs of his parishioners and runs a clinic that handles around 20 patients each day. In recognition of his efforts, the city of Nadur honored him with the Gieh in-Nadur award, which he graciously accepted. Upon his arrival, Fr Raymond encountered an abandoned government school; through his leadership, it has now flourished to accommodate 1,600 students across primary and secondary levels. Furthermore, he established a clinic dedicated to AIDS patients, featuring 15 beds.

While the government supplies the necessary medications, the average age of the patients is just 28. Even if they are not cured, they find solace in dying with dignity, receiving care in a proper environment. To combat drug addiction, he launched the Talita Kumi Centre, through which he actively seeks job opportunities for its attendees. Additionally, the parish has created Casa Betania, a shelter providing nightly refuge for the elderly. Amidst his myriad responsibilities, Fr Raymond also carves out time to teach philosophy and theology at the seminary, along with medical ethics at the university, showcasing his unwavering commitment to both spiritual and educational guidance.

## DOMINICAN CHURCH AND MONASTERY OF BIRGU BOMBED

During World War 2 the enemy bombing in 1941 left the Dominican community of Birgu (Vittoriosa) without their convent and church, and drove them to seek temporary refuge beyond Birgu. But their need to fulfil their duties among their people urged them back to Birgu, where they asked to make temporary use of the Inquisitor's Palace.

Indeed, for almost two decades, the Palace became their home and temple. The current exhibition Dumnikani fil-Palazz: Home & Temple 1942 – 1960, at the Inquisitor's Palace, recounts this story that further strengthened the special place that the Palace enjoys in the Dominicans' hearts.

#### **AIR DISASTERS IN MALTA**







The Zabbar airplane accident can be considered as the biggest air tragedy in Malta since the crash of the Vulcan on Żabbar in 1975 – an incident which had also left five persons on board the

plane dead, together with a Maltese woman.


Malta's aviation history records a number of incidents, some of which can be classified as tragedies, while others had less series consequences.

A news service on the 18th February 1956 recounts an air accident which occurred in Malta when an Avro-York plane crashed in a field in the area known as 'tal-Ġibjun' in Żurrieq shortly after take-off. 50 people on board the plane lost their lives. The aircraft was heading to Stansted in London when the pilot changed the route to Malta due to engine problems. For some reason, it did not land on the runway.

A more grievous tragedy occurred in Rabat, 29 years before. On the 4th of April 1946, a Vickers Wellington aircraft crashed in St Pubius Street. Four crew members and 16 Maltese citizens died; 18 houses sustained structural damages and 72 families ended homeless. The tragedy could have been bigger when the plane closely missed the primary school and St Paul's Collegiate.

Another tragedy hit a village near the airport occurred in the last days of 1952 in Luqa when a

Lancaster aircraft caused structural damages to 14 homes



During a different event in June of 1982, a small plane crashed during the Malta Air Rally at 'Tal-Virtu' near the Seminary. Two people on board died.

In 2006, veteran pilot Gabor Varga was killed during an air display in the Grand Harbour on the occasion of the Aero



Grand Prix of Malta.

The disappearance at sea of a Piper Lance in 1995 was another tragic air incident when the small plane flew to Sicily with a number of persons aboard, but their fate was never known.

Malta Police Force Commemorates Victims of the 1975 Zabbar Air Vulcan XM645 Crash

In a heartfelt tribute, the Malta Police Band performed a moving concert organized by the Ħaż-Żabbar Local Council, marking 50 years since the tragic crash of the Vulcan XM645, one of Malta's most devastating air disasters.

This poignant event honoured the victims of the 1975 tragedy, which left a deep mark not only on the Żabbar community but also on the entire nation.

During the ceremony, Police Commissioner Angelo Gafà placed a wreath at a newly dedicated memorial, paying homage to those who lost their lives in the accident.

The evening was a tapestry of emotion and reflection, uniting the community in remembrance and showcasing Żabbar's enduring commitment to honouring its past five decades later.

#### **BARMAIDS OF STRAIT STREET**

The revival of Strait Street, along with the rest of the capital, has caused widespread intrigue about its raucous history.


Malta has taken a significant step forward by eliminating outdated laws concerning the 'moral conduct of women' in the workplace, a practice that harked back to British colonial times. In September 2025, Legal Notice 185 of 2025 was enacted to dismantle regulations dating back to 1947 that specifically targeted women employed in bars, commonly referred to as "barmaids." These rules imposed a set of conduct guidelines that did not apply to their male counterparts. Among the now-defunct requirements were stipulations such as: - Female employees needed to be at least 21 years old and licensed.

- They were required to wear designated uniforms and badges.
- The establishment's licensee was held accountable for ensuring the "proper supervision and moral conduct" of their female staff.
- Women were prohibited from lingering near the bar's entrance.
- Their licenses could be revoked for supposed breaches of public morality, propriety, or decency.

#### STRADA STRETTA – STRAIT STREET - TRIQ ID-DEJQA – VALLETTA

Strait Street, or Strada Stretta, affectionately dubbed 'The Gut' for its lively yet risqué reputation, was a vibrant hub in Valletta where military personnel sought entertainment from the late 19th century to the mid-20th century. This era was a remarkable chapter in Malta's history, showcasing a blend of diverse nationalities, social backgrounds, and lifestyles, functioning almost as a microcosm of multiculturalism. Maltese locals mingled with British, American, and Italian visitors.

As night fell, Strait Street pulsated with life. In its heyday, the avenue teemed with bars, bordellos, music halls, restaurants, and venues where sailors, barmaids, musicians, and other revellers gathered to escape the burdens of wartime life and enjoy a night of merriment.



Homelessness in Malta is largely hidden due to strong family ties, but it is a real and growing issue driven by factors like rising rent costs and financial hardship. While there are no large visible street populations, organizations like YMCA report thousands of cases, with a significant number involving young people and men. Support services exist through the government's Homeless Service and NGOs, focusing on shelters, social housing applications, and support plans for

independent living.

Contributing factors

- **Financial hardship:** A significant number of homeless cases are due to financial challenges and inability to afford rent.
- **Rising rent and cost of living:** The cost of living has increased significantly, particularly for rent, making it harder for those with stagnant wages to keep up.
- Lack of affordable housing: There is a considerable waiting list for social housing, and many people are at risk of homelessness due to the difficulty in finding and affording adequate housing.
- **Family and domestic issues:** Family problems and domestic violence are also significant contributors to homelessness.

**Demographics** 

- Age: The largest group affected is young people aged 25–34.
- **Gender:** Men are disproportionately affected, with significantly more male cases of homelessness than female cases in recent years.
- Maltese and foreigners: While many Maltese citizens are affected, the issue is also seen among foreigners in Malta.

Support and services

- **Government support:** The government's <u>Homeless Service</u> provides social workers who assess situations and place individuals or families in emergency or long-term shelters. They create joint care plans to help people work toward independent living.
- **NGO support:** Organizations like <u>YMCA Malta</u> offer crucial support, including shelter, counseling, and assistance with job seeking and budgeting.
- **Challenges:** There is a significant waiting list for social housing, and many people leave shelters before their social housing application is processed.

Addressing the issue

- Holistic approach: Solutions need to go beyond emergency shelters and address the root
  causes, such as strengthening family structures, improving rental policies, and mitigating the
  rising cost of living.
- **Focus on prevention:** Efforts are needed to help those at risk of homelessness, not just those who are already homeless. This includes those living in inadequate conditions, those relying on friends or family, and those paying a large portion of their income on housing.

# IT-TERRAMAXKA - KITARRA MAGICA (MAGICAL GUITAR)



Do you know what a TERRAMAXKA is? Entirely made of wood, it produces music through air passing through pipes.

Historically, the terramaxka provided entertainment during village festas and events such as the L-Imnarja feast in Buskett, Rabat, especially when no band was present.

Each terramaxka played about eight melodies, usually waltzes and mazurkas. Some versions featured small moving wooden statues and decorative flags, making them especially appealing to children.

Before the establishment of local bands, the terramaxka played a vital role in Maltese musical life.



Known as the KITARRA MAGICA (MAGICAL GUITAR), the TERRAMAXKA once reigned supreme in the Maltese islands. Different models came from places like France and Switzerland. This captivating instrument brightened local festas, contributed to carnival festivities, and even found its place in the rhythms of everyday life. Mari, who hails from Holland, arrived in Malta in 1977 while working on a ship at the

drydocks. He fell head over heels for both the island and a charming Maltese woman, ultimately deciding to call Malta home. His admiration for the TERRAMAXKA drove him to restore one from 1929, breathing new life into it with some tender care. Sadly, fate dealt a harsh blow when it was lost in a store fire.

Today, Mari proudly owns the last TERRAMAXKA on the islands, and when it is spotted rolling through the capital, it sparks a flood of nostalgia for the locals. Regrettably, the other TERRAMAXKAS have either fallen to the ravages of time, been sold to collectors in America, or met unfortunate fates. Department of Information -Malta


